


Figure 1.1: Picture or figure

You may refer to other chapters/sections/subsections in the thesis like 1; for figures, Fig. 1.1; for tables, Table 1.1; And for equations, (1.1), notice there is no need to add eq. or equation before calling the reference. Make sure the object you are referring has a "label" tag.

3.3 Citation and Bibliography

Concerning citations, you may add references in the file "bibliography.bib" and call them like [1]. Here is another multiple citation example [2, 3]. The bibliography section is updated automatically. Make sure that the reference has the correct information.

Tip: We recommend to use a reference manager to write the bibliography. In particular, Zotero is our preference to generate BibTex code. Get in touch with the Library if you want more information about how to use reference managers.

3.4 Draft Mode

This template comes with draft mode, so you may write TODO comments in the document .

To enable draft mode and TODO comments, type **draft** instead of **final** when you define the document class in thesis.tex, i.e. "documentclass[12pt, **draft**]..." instead of "documentclass[12pt, **final**]..."

IMPORTANT REMARK: Before delivering the final version, make sure that the document is in 'final mode' instead of 'draft mode'!
